Upon school reopening Oct 26th, the Boys & Girls Club will offer limited spots in our full-day program to assist with distance learning for students who have opted out of in-person instruction for students grades K-12. Students will be accepted based on parent occupation, student need, and capacity. The Boys & Girls Club full day program hours will be 9am-5pm.

Please take note of the following-

- **If your child is already enrolled in the Boys & Girls Club's full-day program, and you have opted *out* of in-person instruction, your child's spot will be reserved.**
- **If you choose to opt *out* of in-person instruction, the Boys & Girls Club will accept applications for the full-day program beginning Oct 1st.**
- **If you choose to opt *in* for in-person instruction at your child's respective school, your child will not be eligible to attend the Boys & Girls Club. This will be re-evaluated in December.**

We continue to strive to do as much as we can for our children and community but please understand our capacity is limited due to Covid space restrictions. By keeping the in-person and distance learning groups separate, we hope to keep our kids and community as safe as possible.

Please be aware that these plans are subject to change during these uncertain times. School closures and/or change in start dates will affect what the Boys & Girls Club can offer.
